ISO 9001:2015 (Quality Management Systems)

ISO 9001:2015 sets out the criteria for a Quality Management Systems and is the only standard in the family that can do Certification of every company worldwide. It can be used by any organization, large or small, regardless of its field of activity. In fact, there are over one million companies and organizations in over 170 countries certified to ISO 9001. This standard is based on a number of quality management principles including a strong customer focus, the motivation and implication of top management, the process approach and continual improvement. Using ISO 9001:2015 helps ensure that customers get consistent, good quality products and services, which in turn brings many business benefits.

ISO 14001:2015 (Environmental Management System)

ISO 14001 is an environmental management standard that defines the environmental policy of an organization. This standard helps organizations to protect the environment, check pollution, and improve their overall environmental performance. ISO 14001 is a useful tool for an organization to step up from just maintaining regulatory compliance to an organization with improved productivity and enhanced competitive advantage. ISO 14001 is applicable to any business that wishes to establish, implement, maintain and improve an environmental management system and conform to its stated environmental policy.

ISO 45001:2018 (Occupational Health & Safety Management System)

An OHSMS promotes a safe and healthy working environment by providing a framework that allows your organization to consistently identify and control its health and safety risks, reduce the potential for accidents, aid legislative compliance and improve overall performance. ISO 45001 is the internationally recognized assessment specification for occupational health and safety management systems. It was developed by a selection of leading trade bodies, international standards and certification bodies to address a gap where no third-party certifiable international standard exists.

ISO 22000:2018 (Food Safety Management System)

ISO 22000 is a Food Safety Management System that can be applied to any Organization in the food chain, farm to fork. Becoming certified to ISO 22000 allows a company to show their customers that they have a food safety management system in place. Saving you time and money. As an integrated programme, ISO 22000 implementation avoids the cost of multiple audits. Food safety management systems based on ISO 22000 promote continuous improvements in processes and performance, which can help your business become more efficient and because ISO 22000 is respected by governments and food safety experts worldwide, certification can open your business to new markets.

ISO/IEC 27001 (Information Security Management System)

The ISO/IEC 27001 standard was published in October 2005, essentially replacing the old BS7799-2 standard. It is the specification for an ISMS, an Information Security Management System. BS7799 itself was a long standard, first published in the nineties as a code of practice. As this matured, a second part emerged to cover management systems. It is this against which certification is granted. Today in excess of a thousand certificates are in place, across the world. The objective of the standard itself is to "provide a model for establishing, implementing, operating, monitoring, reviewing, maintaining, and improving an Information Security Management System". Regarding its adoption, this should be a strategic decision. Further, "The design and implementation of an organizations ISMS is influenced by their needs and objectives, security requirements, the process employed and the size and structure of the organization.

ISO 50001:2018 (Energy Management System)

Certification to this standard demonstrates an organization's commitment to continual improvement in energy management, allowing them to lead by example within their respective industries and ensure related legislative and regulatory requirements are met. Organizations are not able to control energy prices, national country policy or the global economy, however, an organization can improve the way they manage energy.

HACCP (Hazard Analysis and Critical Control Points)

HACCP system allows you to identify hazards and put in place controls to manage these throughout your supply chain during production. It can also be used to support the requirements of management standard requirements.



The preventive approach of HACCP not only improves food safety management but also complements other quality management systems. Food safety management systems built in accordance with the principles of HACCP have a clearly defined structure.

GMP (Good Manufacturing Practice)

GMP is a system for ensuring that products are consistently produced and controlled according to quality standards. It is designed to minimize the risks involved in any pharmaceutical production that cannot be eliminated through testing the final product. GMP covers all aspects of production from the starting materials, premises and equipment to the training and personal hygiene of staff. Detailed, written procedures are essential for each process that could affect the quality of the finished product. There must be systems to provide documented proof that correct procedures are consistently followed at each step in the manufacturing process - every time a product is made.

CE MARK

CE Marking is a symbol. The letters "CE" are the abbreviation of French phrase "Conformité Européene" which means "European Conformity". If the product meets the provisions of the applicable European Directives, and the CE mark is affixed to a product.
